

Notably, our site was recognized as the Top Enroller in the United States for the APC-APN-305 study, reflecting our unwavering commitment to advancing pulmonary care through high-quality clinical research.

## Enrollment Updates

As of September 3, a total of **69 sites** have randomized **646 patients** (639 in main cohort and 7 in GLP-1 cohort), which represents an additional **227** patients since the previous newsletter that was sent on July 17th!

## CASE STUDY

Revival Research Institute's collaboration with Apnimed achieved remarkable success in advancing research for obstructive sleep apnea. Initially tasked with screening 53 patients, Revival exceeded this target, successfully screening 64 participants—a 20% increase over the original goal. This was accomplished through a proactive, community-centered recruitment strategy, engaging potential participants at local health events such as the Senior Expo and the Ann Arbor Art Fair. Revival's diverse outreach enabled the institute to connect with a broader patient population.

Retention rates during the 6-month trial also remained consistently high, underscoring Revival's dedication to personalized patient care and commitment to maintaining participant engagement throughout the study. This success was driven by the institute's robust follow-up systems, continuous communication, and patient-focused support, which kept drop-out rates at a minimum.

Revival's ability to exceed recruitment targets and maintain high retention rates highlights expertise in clinical trial management, making it a trusted partner in advancing healthcare research.
